1. Contractor/ Firms should have Class I and II registration under A.P.W.D./ C.P.W.D/ other Govt. agencies.
2. They should furnish up to date registration Certificate (Photocopy) along with the quotation.
3. They should furnish Pan Card, Bank Account details (Photo copy)
4. They should furnish financial soundness Certificate from any Institution or last work done certificate. (like photocopy of work order of any Govt. or Private department)

## **Terms and condition for quotationer**

1. The rate quoted shall inclusive of all taxes, forest royalties or any dues payable to Govt. of Assam.
2. The materials should be superior in quality and measured in full.
3. Test Certificate from any manufacturer or laboratory should furnish along with bill.
4. The rate should not differ excessively to the Govt. approved rate prevailing in the market.
5. The rate should be inclusive of carrying, loading and unloading at work site.
6. Mode of payment will be done as per guideline of RUSA/ PFMS in bank.
7. Materials when supplied shall be verified by the Supervisor/ in-charge of site or Engineer in site.
8. Bills shall be verified and checked before final payment made time to time.
9. Construction committee has the right for rejection of any quotation without showing any reason thereof.
10. Construction committee along with the Engineer In-charge have the right to reject any supply material (s) which are seems to be inferior.
11. Rejected materials should be removed from the site at their own cost.
